- Right on the heels of the new Alameda Admin show, comes the <u>John Muir Aspen Surgery Center Show</u> (Rick Nelson Show Chairman <u>rixingm@gmail.com</u>). You'll need to pre-register for this show as well -- the artwork will be collected at the Law Library on Thursday February 27th between 10 and 11am (the same time/place as the pick-up of entries from the current Law Library Show). Complete details for this show are also attached.
- Our effort to begin <u>pre-registering artwork for our Juried Shows</u> is paying off, although it's a process and some minor tweaking may still be needed:
 - All you need to do to pre-register for these shows is to take a picture of the individual art, and second photo of the completed entry form, and email them to the respective show chairman. **Do it with your phone it's really easy!** If you would rather type your entry details in an email that's OK too.

EXHIBITION LOCATION:

Alameda County Administration Building, 1221 Oak Street, Oakland, CA 1st Floor, Treasurer-Tax Collector's Lobby Gallery. The Alameda County Treasurer-Tax Collector's Gallery is an attractive space close to the building entrance. Thousands of visitors will view the artwork over the course of the exhibition. This is a great opportunity to share your artwork with the public (Note the drop off and pick up locations are elsewhere.)

EXHBITION DATES: Monday, February 24 to Thursday, August 6, 2020.

This show will be up for five and a half months. Artwork cannot be removed before the show closes.

PRE-REGISTRATION DEADLINE: Friday, Jan. 31, 2020

To pre-register and submit your artwork for consideration for this exhibition, email John Henry at johnfranklinhenry@gmail.com by Friday, Jan. 31 with the titles and sizes of your entries. You **must** attach jpegs of each artwork. All types of painting, drawing, photography and digital art, collage, and printing are acceptable for this show. No 3-D work.

NOTIFACTION OF ARTISTS: February 12, 2020.

Artists will be notified of the standing of their submissions by close of business on Feb. 12.

THEME:

The goal of the exhibition is to celebrate the rich diversity of people, places, and the natural environment throughout Alameda County. Alameda County includes 14 cities and 6 unincorporated communities. The county extends to Albany in north to Fremont in the south county. Alameda County has many urban cities such as Oakland, Berkeley, Hayward and Fremont as well as more suburban and rural areas to the east such as Livermore and Pleasanton. If you are unsure if your artwork would be appropriate for this show, please contact the show chairs in advance.

SHOW CHAIRS: John Henry (johnfranklinhenry@gmail.com), Sonia Tamez (sonictamez@gmail.com)

JUROR: To be announced.

AWARDS: First \$100, Second \$50, Third \$25. Honorable mentions to be awarded at the discretion of the juror.

ENTRIES:

Up to 3 entries will be accepted per member. Entries must suitable for wall-hanging. The outside dimension of size of each piece (including the frame) must be **no smaller than 12"x12"** and **no larger than 36"x36"**. To be entered as a single work, any grouping of 2 or more works must be mounted within a single frame which meets the overall size requirements.

All work must be original work – no class work or copies. All artwork must be appropriate for all ages in a highly visited public service exhibition space. Inappropriate imagery for this location includes, but is not limited to, nudity; religious or political content; and depictions or references to violence, drugs, gangs, illegal, or controversial activities. Work deemed inappropriate by the show chairs will not be accepted.

ENTRY FEE: \$10 per entry

FRAMING:

The artworks should be framed where possible. Unframe work such as stretched canvas must have painted edges and have a clean and professional appearance. Mats must be clean and well cut.

No deep frames (exceeding 3" from the wall) or elaborate frames will be accepted. Frames must be clean and sturdy, with no protruding screw eyes or hangers. The frame must have a wire on the back and be ready to be installed. Glass glazing is not allowed; plexiglass is acceptable.

DROP-OFF: Thursday, February 20, 10am to 1pm

Drop-off of exhibition artwork will be on at the home of Sonia Tamez, 6012 Chabolyn Terrace, Oakland (about ¾ of a mile from the Rockridge Bart Station). NOTE: artwork must be boxed in cardboard boxes – the box the frame came in if possible.



AWARDS: First award \$100; Second award \$50; Third award \$25. Merit awards are given at the discretion of the Juror.

ENTRIES: Up to 3 entries will be accepted per member.

- Entries will be two dimensional; <u>The sides (including the frame) must measure at least 17" x 21"</u>, but no more than 46" in either direction.
- Works restricted to original work no class work or copies.
- All work must be for sale and be priced under \$1500.
- All work having won cash awards in any OAA show is not eligible to receive another cash award but may receive a merit award.
- John Muir Medical Center reserves the right to refuse to exhibit any work of art which it determines
 at its sole discretion to be unsuitable for exhibition in the hospital setting. Included in the unsuitable
 category are nudes and any subject which could be construed as being of a religious or political in
 nature.

FRAMING:

- Frames must be clean, sturdy and no protruding screw eyes, or hangers will be allowed.
- No glass is allowed in the frames at any OAA Show. If covered -- plastic must be used.

All sales made during the show and/or 30 days following the close of the show (if the work was seen by the buyer at the show) will be handled by the Sales Chair (Rick Nelson 925 989-9183).

OAA policy is that no change will be made in the price (in connection with this show) after the work is accepted. The artist agrees that 30% of the sale price will be held back as a donation to the OAA Educational Fund. Sales tax of 9.25% will be added to all sales.
