- Next up are back to back **Photography shows**. The talent common to all successful visual artists has much to do with style, composition, color sense, imagination and ability to recognize the combinations of elements that work well together. You may not call yourself a photographer, but you have the “gift” and if you look through your pictures, you’ll prove it to yourself. It’s not about fancy gear, it’s the eye behind the camera that makes all the difference. **Please share your talent in both shows!!**
  - First will be the annual **Photography Show at the Law Library during April**. The rules for this show are attached for your reference. Please note the take-in date for this show has changed –it will be at the Law Library on Monday April 6<sup>th</sup>.
  - Next will be the **“Smart Phone Photo Show” at the Rockridge Library during May**. We’ve talked about this show for several years, but it is going to happen in 2020. The rules for the show will be published in a few weeks. You’ll be surprised! (Tony Kay has agreed to be the Show Chairman.)
- **Pre-registering artwork for our Juried Shows:** The new procedure is working well, although some minor tweaking may still be needed.
  - All you need to do to pre-register is to take a picture of the individual art, and a second photo of the completed entry form, then email them to the respective show chairman. **Do it with your phone it’s really easy!** If you would rather -- simply email the entry details -- and that’s OK too.
    - If taking / emailing the photo of your entry is a technical challenge for you, please just email the entry details to the chairman, and (s)he will snap the required photo when you drop off the art.
    - Please begin using the **revised entry forms!** (also attached) Fill the form out and **initial the liability** waiver section
      - Tape the original form to the back of your art.
      - Attached to this email are entry forms for your use, you can print it and fill it out by hand, or you can open it on your computer and fill it out with the keyboard before printing. (Thanks to Tony Kay for this improvement!)
      - Questions or difficulties? – Please contact the Show Chairman.
- Also included as an attachment to this email is the **updated Juried Show Schedule** for 2020. Several dates had to be revised to accommodate other activities at the Law Library.

**TAKE-IN:** Monday, April 6<sup>th</sup>, 2020 between 10 and 11am at Law Library 125 12<sup>th</sup> Street, Oakland, in conjunction with the pick-up of the John Muir Hospital Show.

**PICK-UP:** At the Law Library on Friday May 1<sup>st</sup>, 2020 between 10 am and 11am. (Alternatively, members can pick up their entries on the following day May 2<sup>nd</sup> at the Rockridge Library Smart Phone show take-in)

**ENTRY FEE:** \$10.00 per entry collected at the take-in.

**AWARDS:** First award \$100; Second award \$50; Third award \$25. Merit awards are given at the discretion of the Juror.

**JUROR:** TBD

**PRE-REGISTRATION:** Please email [rixingm@gmail.com](mailto:rixingm@gmail.com) on or before Saturday April 4<sup>th</sup> with entry details, including: **Medium, Title, size, price, and a digital image of the entry(s)**. (pre-registration can be as simple as a cell phone photo of the artwork **and** a second photo of the completed entry form, emailed to the address above.)

**ENTRIES: Up to 4 entries will be accepted per member.**

- Entries will be two dimensional
- Most entries will be 8"x 10" minimum up to 30"x 30" maximum. This venue will also allow several larger pieces, please contact the Show Chairman.
- Works restricted to original work – no class work or copies.
- All work must be for sale.
- All work having won cash awards in any OAA show is not eligible to receive another cash award but may receive a merit award.
- The Alameda County Law Library reserves the right to refuse to exhibit any work of art which it determines at its sole discretion to be unsuitable for exhibition in the library setting. Included in the unsuitable category are nudes and any subject which could be construed as being of a religious or political in nature.

### **FRAMING:**

- Frames must be clean, sturdy and no protruding screw eyes, or hangers will be allowed.
- No glass is allowed in the frames at any OAA Show. **If covered -- plastic must be used.**

**ENTRY FORMS:** Please use the new entry form, filled out completely and affixed to the upper left-hand corner on the back of the entry. **The Insurance Waiver is part of this entry form must be initialed.**

### **SALES:**

All sales made during the show and/or 30 days following the close of the show (if the work was seen by the buyer at the show) will be handled by the Sales Chair (Rick Nelson 925 989-9183).

OAA policy is that no change will be made in the price (in connection with this show) after the work is accepted. The artist agrees that 30% of the sale price will be held back as a donation to the OAA Educational Fund. Sales tax of 9.25% will be added to all sales.
